FIRST WITNESS STATEMENT OF INSPECTOR PAUL HOLMES

I, **Inspector 24253 Paul Holmes** based at Andover Police Station, South Street, Andover SP10 2ED will say as follows:

1. I am Inspector 24253 Paul Holmes, a police officer for Hampshire Constabulary. I am the Test Valley District Inspector based at Andover Police Station and have held this post since May 2023.
2. I make this statement in support of the claimants on-going claim for an injunction against named Defendants and Persons Unnknown. The facts in this witness statement come from my own knowledge, or where they are not from my own knowledge, they are true to the best of my knowledge and belief.
3. I am aware that my predecessor Inspector Chris Taylor has given evidence within these proceedings setting out the evidence held by Hampshire

Constabulary in respect of unauthorised encampments within the Test Valley area.

4. I understand that Inspector Taylor's last evidence updated the Court up to and including an encampment at Foxcotte Park Sports Ground in Andover on 12th August 2022.
5. I make this statement to update the Court as to the unauthorised encampments in Test Valley which have come to the Police's attention since 12th August 2022.
6. I have compiled a further list of the 19 incidents that Hampshire Constabulary have dealt with relating to unauthorised encampments since the date of Inspector Taylor's last statement to the Court (11th June 2020) to August 2022.
7. I have compiled the reports in relation to each of these incidents and exhibit these to this witness statement at exhibits "PH1" – "PH19".
8. I refer to the following reports in connection with unauthorised encampments, and linked crimes and incidents, from 31st August 2022 to 5th December 2023. Full details can be seen in the exhibits I mention above, which I also summarise them as follows, taking the earliest first.
9. **31/08/2022 Red Post Lane SP11 8DB, 44220354988** A report was received of a caravan forcing entry onto a field, causing damage to the gate. Officers spoke to Mr Albert Bowers. Margaret Bowers was also present along with Tom Bowers. I exhibit the reports relating to this incident hereto marked "PH1".
10. **07/09/2022 North Way, Andover, SP10 5AZ.** Reports relating to this incident **44220365728** are exhibited hereto marked "PH2" An unauthorised encampment four cars and five caravans set up in 18-19 North Way, Andover, a Bookers Cash and Carry Unit. It is believed this is a group that were moved

on by Bailiffs from a site in Winchester. Bailiffs were engaged to move the group on and police presence was requested by the Bailiff as the group had been trouble in Winchester – one of the Bailiffs recognised the group who had become violent during the Winchester eviction where a police car had been damaged.

11. 21/02/2023 Rownhams West Service Station 44230072078 Exhibit PH3-

An informant reported that a group of travellers had parked up on the Service Station Car Park. Reports of theft from the stores in the service station were received. Reports were received of the encampment being fully set up with generators running, dogs tied up and children running around the site. It was reported that children were attempting to steal from the shops and when challenged saying “do you want us to bring our whole family in.” Shop owners reported feeling threatened and requested police support. A report was received of shops closing early due to concerns for staff safety. Vehicles registered to Thomas McDonagh and Michael McDonagh were present. Reports show approximately 30 persons, and 10 vehicles were on the land. The group left of their own accord.

12. 24/05/2023 Watery Lane, Andover 44230205111 . Exhibit PH4. A member of public reported that six caravans, 2 cars, 1 pickup truck and approximately 12 adults and 8 children had set up on a privately owned field. The gate had been lifted off and moved.

13. 30/05/2023 Clover Way, Romsey, SO51 7RG 44230214510. Exhibit PH5 – A report was received of 2 caravans and 3 cars setting up on a green area at Clover Way with screaming and shouting. A report notes that they had left the following day leaving rubbish and clothing.

14. 03/06/23 Smannell Road, Andover SP11 6UN 44230219806 Reports relating to this encampment are exhibited hereto marked “PH6”. An encampment was established on public open space at Smannell Road, Andover comprising approximately five vehicles with a number of caravans. They stated that they had travelled from Newbury and intended to stay three

or four days, that they had two children and no welfare concerns. The group declined to give their names, but vehicles registered to Wayne Cole, Tina Wickens and Philip Conelly were present. I believe this is the same group who were reported when they stopped at Churchill Way West Andover before moving on to the Smanell Road site. A copy of reports reference 44230219775 is exhibited hereto marked "PH7".

15. **03/06/2023 Ridges Close, Little London SP11 6JE** A report was received of approximately half a dozen individuals setting up an in a field. A copy of the reports under reference **44230219853** is exhibited hereto marked "PH8".

16. **07/06/2023 Augusta Way West, Andover SP11 6FY** Reports were received of an unauthorised encampment setting up on Smannell Road near August Way. Copies of the reports under reference **44230226007** are exhibited hereto marked "PH9". Vehicles present were registered to Patrick Joseph Collins and Martin McDonagh. Two linked crimes are reported; under references **44230229085** where three individuals are reported as pushing their way through the turnstiles and Andover Leisure Centre and refusing to leave and **44230227548** where it was reported that a group of three females and a child stole £182 worth of goods from an Asda store. These reports are also exhibited in "PH9".

17. **22/06/2023 Tweed Close, Chandlers Ford SO53 4QX.** A report was received of 7 vehicles gaining access to the car park of a recreation ground on Glendowan Road Chandlers Ford. A copy of the reports under **44230249199** are exhibited hereto marked "PH10". Circa 9 vehicles and caravans were present. Damage was caused to the padlock of the height restricting barrier to gain access. Five reports were received of human faeces related to the encampment along with a report of litter. One report included a sighting of a member of the encampment defecating in the woods where human faeces and toilet paper was found. Those related to the encampment were reported as defecating in the river with toilet paper also being present in the river. Used nappies and soiled shorts were also reported. The reports

show the Claimant Test Valley Borough Council issuing and serving court proceedings on the encampment.

18. 17/07/2023 Romsey Rapids Sports Centre, Southampton Road, Romsey.

The reports with reference to incidents **44230287813**, **44230289877** (Public Order) **44230289430** (Anti-Social Behaviour) and **44230288836** (Assault) are exhibited hereto marked "PH11". Reports received of circa 10 caravans setting up an unauthorised encampment on the playing field next to the Romsey Rapids Centre. Reports were received of barriers being broken to gain access. Neighbouring businesses reported some of those from the encampment climbing on their gate. Numerous reports were received from the Romsey Rapids Sports Centre of those from the encampment causing a nuisance including setting off the fire alarm. The Claimant confirmed that the Sports Centre advised that the Centre had to be closed for a time for security reasons, that the adventure golf facility had to be closed and locked, the cricket rugby clubs were advised they couldn't train and a security guard was commissioned to support the reception and to carry out night patrols. Reports were received:

- a. from a bailiff attending to serve notice concerned about a fight at the encampment **44230288836**
- b. from the sports centre reporting youths from the encampment running about, using the showers and pool, being rude to staff and setting off the fire alarm **44230289430**
- c. from the sports centre when a male from the encampment had demanded to use the showers and refused to pay, using abusive language and displayin agreesion to the staff and using the showers anyway **44230289877** CCTV showed the male going in, using the shower and being aggressive. Officers could not locate the male.

I understand that the Claimant obtained an order from the Magistrates Court under the Criminal Justice & Public Order Act 1994 requiring the encampment to vacate. They did so when bailiffs attended.

19. 20/07/2023 The Recreation Field, Stanbury Road, Thruxton, SP11 8NS A

report was received of an unauthorised encampment of 4 vehicles and 3 caravans on a charity-owned field in Thruxton near Andover. A female present confirmed she was 'Margaret' but refused to give a surname. RMA and PNC searches suggest that those present were Michael Bowers, Albert Bowers, Joe Bowers and Margaret Bowers. Vehicles present were registered to Mr Albert Bowers and Mr Joey Bowers. Reports were also received of aggressive dogs on site. Reports relating to this encampment are exhibited hereto marked **"PH12"**.

20. 30/07/2023 South Holmes Close, Ampfield, SO51 9BD A report was

received of an encampment of three caravans on privately owned caravan site land south of Holmes Copse. Reports of a mess being made; private bailiffs were engaged. The reports relating to this incident are exhibited hereto marked **"PH13"**.

21. 01/08/2023 Saxon Fields Pavilion, Andover, SP10 4NP. Police attended

following a report of an unauthorised encampment on the recreation ground. A male identified himself as Martin McDonagh. He stated that there were 15-20 children on the site and they intended to stay for a couple of days as they were on their way to a wedding. Members of public reported that a padlock had been cut to gain entry to the field. Vehicles present were registered to Mr John McDonagh (x4) Martin McDonagh (x2) and Paul Jones. The reports **44230309748** relating to this encampment are exhibited hereto marked **"PH14"**.

22. 11/08/2023 Andover Business Park, SP11 8EZ. A report was received of 10


caravans entering the Co-op HGV site at Unit 4, Pioneer Road, Andover. The report included disruption to Co-Op Lorries being able to enter due to children from the encampment playing in the road. Those on the encampment stated they intend to stay about a week unless moved on before that. A copy of the reports relating to the incident is exhibited hereto marked **"PH15"**.

23. **14/09/2023 Picket Twenty Sports Pavilion, Andover, SP11 6UF.** An encampment of circa 13 caravans and associated vehicles was established on the public open space along with two horses and several dogs. Reports were received of a member of the public being bitten by a dog at the encampment. Two separate reports of dog walkers and their dogs being chased by dogs from the encampment with abuse and threats received when asked to control their dogs. A report was also received of a car being driven over the grass on the playground. The reports **44230375535**, **44230376463** (Public Order) and **44230375626** (dangerous dog) are exhibited hereto marked **"PH16"**. A notice under section 61 of the Police, Crime, Sentencing and Courts Act 2022 was served, and the encampment left.
24. **15/09/2023 North Way, Andover, SP10 5AZ.** It was reported that the group from Picket Twenty described at the above paragraph resettled at the Old Bookers site off North Way, Walworth Industrial Estate, Andover. A public order matter is recorded, when a security guard reports that an individual from the encampment told him to leave or he would be shot in the forehead with a shotgun. A linked report when threatening behaviour was exhibited at the nearby leisure centre is also recorded. The reports relating to this encampment **44230377638**, **44230378796** and **44230378464** are exhibited hereto marked **"PH17"**
25. **18/09/2023 South Way Andover.** A report was received of an encampment occupying the industrial estate at South Way, Andover. The reports relating to this matter are exhibited hereto marked **"PH18"**
26. **05/12/2023 School Lane, Chandlers Ford, SO53 4NQ.** A report was received of an encampment of 8 caravans with several other cars and vans was occupying a warehouse carpark on privately owned land in an industrial area. Despite assurances that they would leave the following day, they remained in situ, smashed a window of one of the buildings, opened fire doors and occupied the building. Electrical connection had been made via the broken window. It was reported that when contractors arrived to board up the broken window, the group threatened violence. A photograph of the broken

window along with the other reports are exhibited hereto marked "PH19". The encampment left on 08/12/2023 and the building owner hired a private security firm.

I believe that the facts stated in this Witness Statement are true. I understand that proceedings for contempt of court may be brought against anyone who makes, or causes to be made, a false statement in a document verified by a statement of truth without an honest belief in its truth.

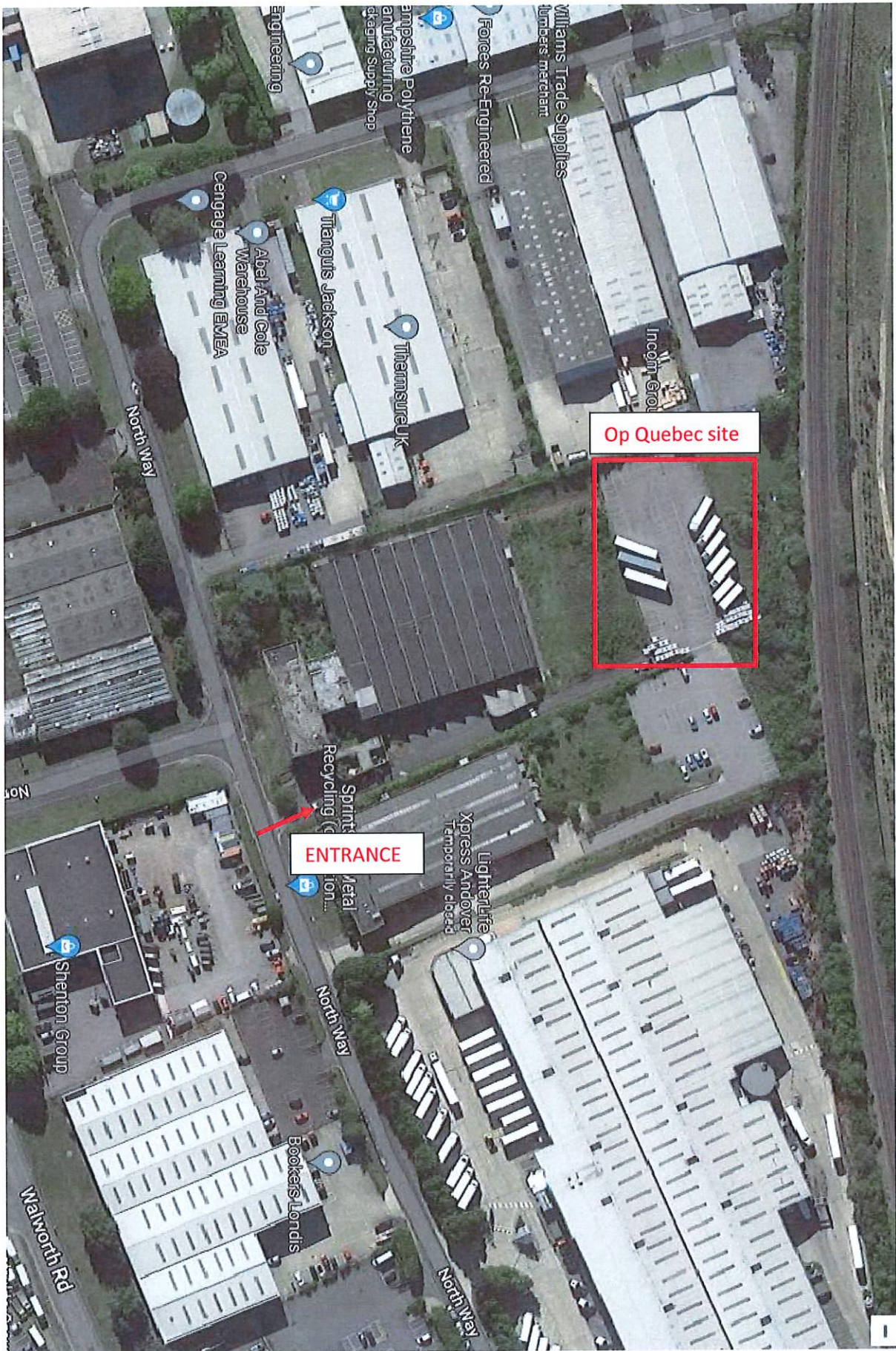
