ARTICLE 5(4) DIRECTION

WHEREAS THE TEST VALLEY BOROUGH COUNCIL ("the Council") being the appropriate local planning authority within the meaning of Article 4 of the Town and Country Planning General Development Order 1988 ("the Order") are of the opinion that development of the description set out in the First Schedule hereto should not be carried out on land at Allens Copse, Shootash, Romsey in Hampshire, ("the Land") being the land shown edged red on the plan annexed hereto, unless permission therefor is granted upon application made under the Town and Country Planning General Development Order 1988.

AND WHEREAS the Council are further of the opinion that development of the said description would be prejudicial to the proper planning of their area and would constitute a threat to the amenities of that area and that the provisions 4 and 5 of Article 5 of the Order should apply to this direction.

NOW THEREFORE the Council in pursuance of the powers conferred upon it by Article 5 of the Order hereby direct that the permission granted by Article 3 of the Order shall not apply to development on the Land of the description set out in the Schedule hereto

11. B. Administration

THIS DIRECTION is made in pursuance of the provisions of Paragraphs 4 and 5 of Article 5 of the Order and shall remain force until 29 for $S_{EPTEMBER}$ 1993 being 6 months from the date of the Direction) and will then expire unless it has been approved by the Secretary of State for the Environment before that date.
